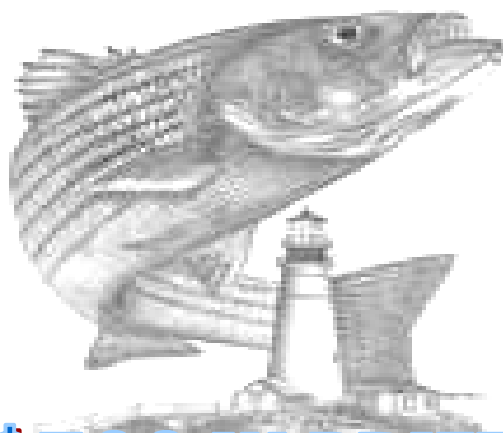

THIS TOURNAMENT STARTS AT 6:00PM ON FRIDAY NOVEMBER 12TH AND WEIGH-IN IS 4:00PM ON SATURDAY NOVEMBER 13TH. YOU CAN START FISHING AT ANY TIME BETWEEN THOSE HOURS. **THIS IS A HONOR TOURNAMENT.**

YOU MAY LAUNCH AT ANY RAMP YOU WISH BUT WEIGH-IN IS AT COBB'S MARINA AT 4:00PM SATURDAY SHARP. NO FISH WILL BE WEIGHED IN AFTER 4:00PM.

ALL VIRGINIA STRIPED BASS RULES AND REGULATIONS APPLY. SO PLEASE READ THEM THOROUGHLY. REMEMBER YOU CAN ONLY POSSESS 2 FISH PER PERSON AT ANYTIME EVEN THOUGH THIS TOURNAMENT GOES FROM FRIDAY TO SATURDAY.

FISH WILL BE JUDGED BY WEIGHT. IN THE CASE OF A TIE, WE WILL GO BY LENGTH. IF THERE IS STILL A TIE, THEN THE FIRST FISH REGISTERED WILL BE THE WINNER AND THE OTHER WILL BE SECOND PLACE.

WEIGH MASTERS AND JUDGES HAVE THE FINAL SAY. ANY PROTEST MUST BE ADDRESSED TO THE JUDGES AT THE TIME THEY ARE FOUND.
